F	<u>Housing/Homelessness</u> . Interaction between our positions to provide shelter and aid as well as affordable housing and the responsibilities of various government agencies.
B	<u>Local Education/LAUSD</u> . A look at current positions on governance and accountability for the school districts in LAUSD.	G	<u>Election Integrity/Instant Runoff Voting</u> . Two topics relating to the election processes and preserving the fairness and integrity.
C	<u>City Finance</u> . A continuation of the local study, focusing on the impact of pension plans on the city budget.	H	<u>Revolving Door/Police</u> . Continuing the R.D. series examining rehabilitation and reentry problems and a related topic updating the local law enforcement position re immigration, community policing, and the consent decree..
D	<u>Health Care</u> . Another "hot topic" currently being considered by all levels of government.	I	<u>Campaign Finance</u> . Several ideas are still circulating among legislators--local, state, and national.
E	<u>Sustainable Communities/Global Warming</u> . Top priority on many government and community organization levels.	J	<u>Special Events</u> e.g., LWVUS Programs such as "Openness in Government," (called Sunshine Week), March 16-22, a national coalition of media and NGOs investigating open government ("sunshine laws"); "Constitution Day," September 17 collaborating to celebrate the day the constitution was signed

Driving Directions:	Parking Directions:
From 101 Southbound – Exit on Los Angeles Street. From 101 Northbound — Exit on Alameda St (Union Station), turn left on Arcadia, then left onto Los Angeles Street, or Exit on Spring St, south to Temple, then south on Los Angeles St. From 110, continue to merge onto 101 Southbound, exit on Los Angeles St	You must drive south on Los Angeles Street to access City Hall East (across from LA Police Department Parker Center), turn into parking garage, check in at kiosk and drive to P2. Take elevator to lobby.

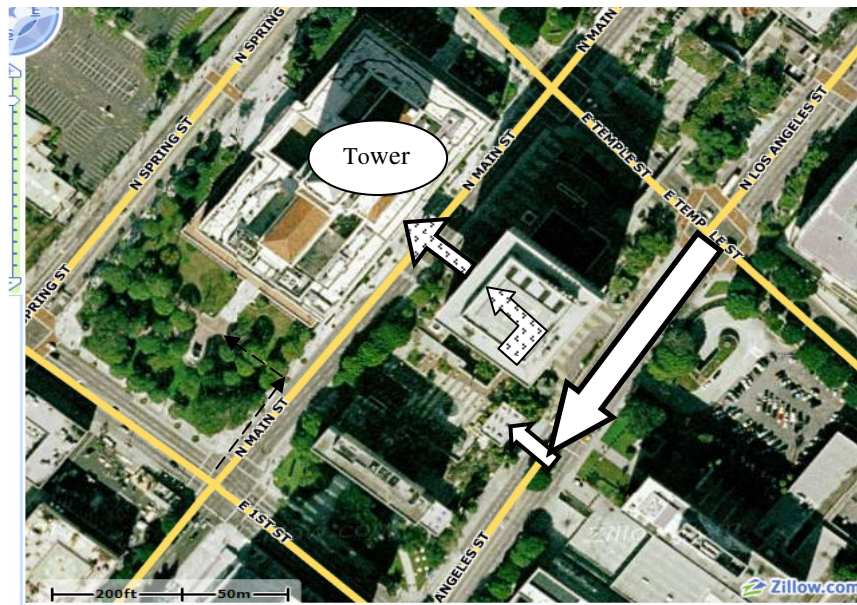
Public Transportation:

Metro Rail, Red Line Exit at Civic Center, which is at Hill between Temple and 1st Sts.

For other bus or rail line, please check with your bus or rail provider to determine Saturday service.

Entrance to Building:

If not parking in the garage, enter building on Main Street, check in at reception desk. If parking in garage, take elevator to lobby floor, cross street to Tower Building. Take elevators which go to the 23rd floor, then change to the elevators (in the next bank) which go to the 26th floor. Check in at registration table. From there you may use either the stairs to the banquet hall or use the special elevator (in the next bank) which goes directly to the 27th floor.
